WHEREAS, in the event of a conflict between these Regulations and any previously adopted regulations regarding this subject matter, these Regulations shall control;

NOW THEREFORE, in accordance with the foregoing, the Association hereby adopts the following Regulations:

I. Parking and Prohibited Vehicles. Reference CCR, Article VI, Section C,

- Per the Declaration of Covenants, Conditions and Restrictions for The Reserve at Cypress Creek Community Association, Inc., and by resolution of the Board of Directors, the operation of certain recreation type vehicles, including but not limited to, ATVs, 4 wheelers, golf carts of all types, trail bikes, unlicensed scooters, etc. are prohibited on any of The Reserve at Cypress Creek streets or greenbelt areas or common areas.
- Only street legal vehicles driven by licensed drivers are permitted to be on our private streets.
- No motorized vehicles are allowed on the sidewalks in the greenbelt or common areas.


